#### **Who is NMCC?**

Namibia Medical Care Clinics (NMCC) is a healthcare initiative that offers quality, accessible and affordable medical cover and services, delivered via strategically-placed mobile clinics, to the uninsured employees in Namibia. NMCC aims to provide comprehensive medical cover for employees who currently do not belong to a private medical aid fund.

#### **Private Primary Healthcare For Your Domestic Worker**

**For Domestic Workers, the Mobile Clinic will be located at Maerua Mall (next to Methealth Namibia Administrators) every Wednesday morning from 08h30 – 10h30.**

**However, you can take during the week your Domestic Worker to other locations in Windhoek where the Mobile Clinics will be stationed. These locations and time will be communicated to you weekly. You can even register your Domestic Worker's spouse and children on NMCC. REMEMBER, the NMCC Service is only currently available in Windhoek**

## NMCC Rules

### Criteria for membership

1. This option is compulsory for all employees within an employer group that are uninsured at present and who earn less than N\$ 5 000 per month;
2. Prior approval will have to be obtained from NMC to allow employees currently insured under a NMC option to join this option. Approval shall only be granted under special circumstances;
3. The monthly premium per employee must be collected and paid over to NMCC by the employer;
4. Membership is restricted to the employee and does not include any family members;
5. A service fee of N\$15.00, payable upfront, will apply for every consultation / visit to the clinic.

### Benefits

1. There will be no exclusions;
2. The members will receive membership cards;
3. Short waiting period as member is consulted on site by a registered medical doctor / nurse;
4. Appropriate medication is dispensed on site.

### General

1. The employer will receive regular updates on the status of medical care provided to its employees without compromising member privacy;
2. Membership cards are kept by a designated official of the employer and for additional control only issued to the employee when needed for a visit to the onsite clinic. After the visit the membership card must be returned to the designated official of the employer.
